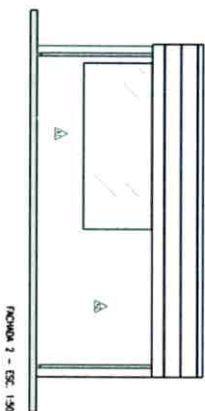
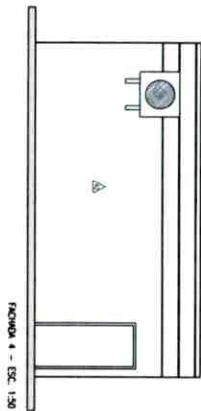
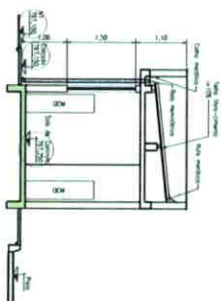


FIGURA 2 - ESC. 150
